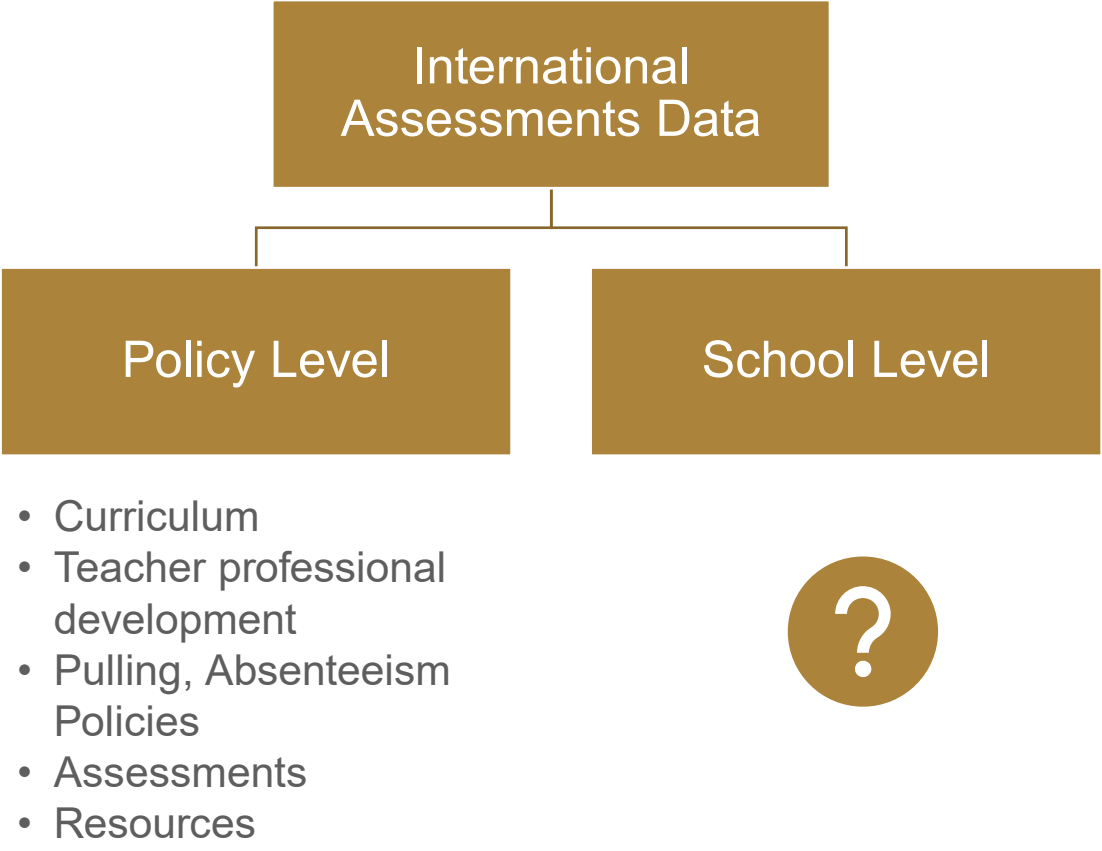
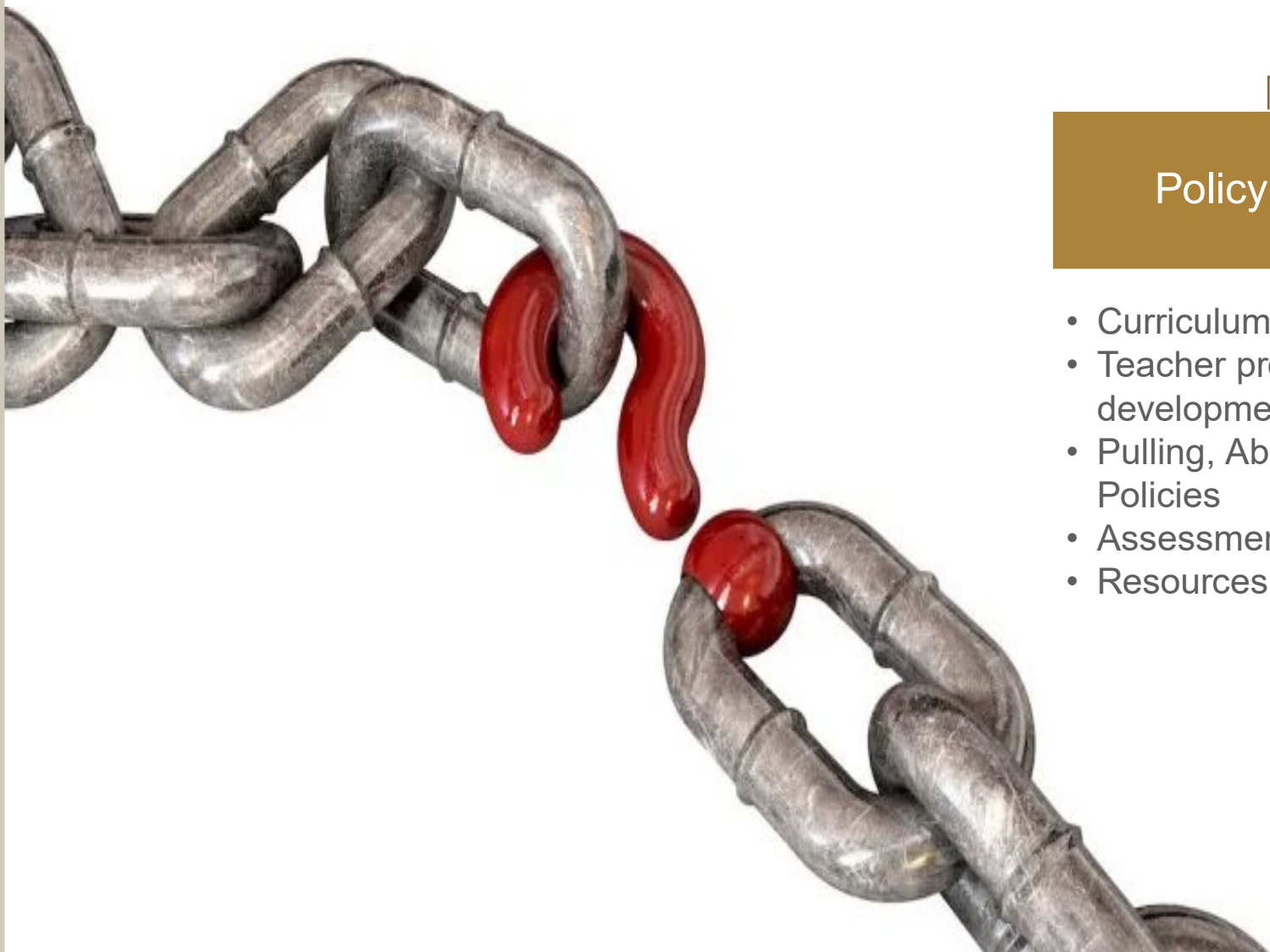

- **Distribution and Training:**

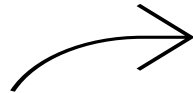

Development of specific educational materials tailored to address these gaps.



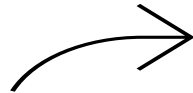
- Development of materials based on identified needs such as research and reports, policy briefs, and study guides.

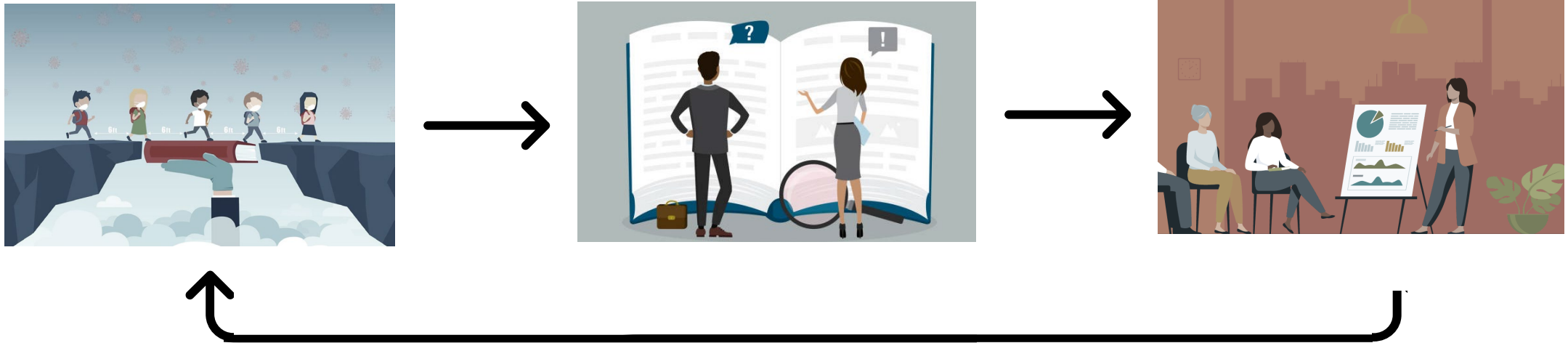
- **Distribution and Training:**

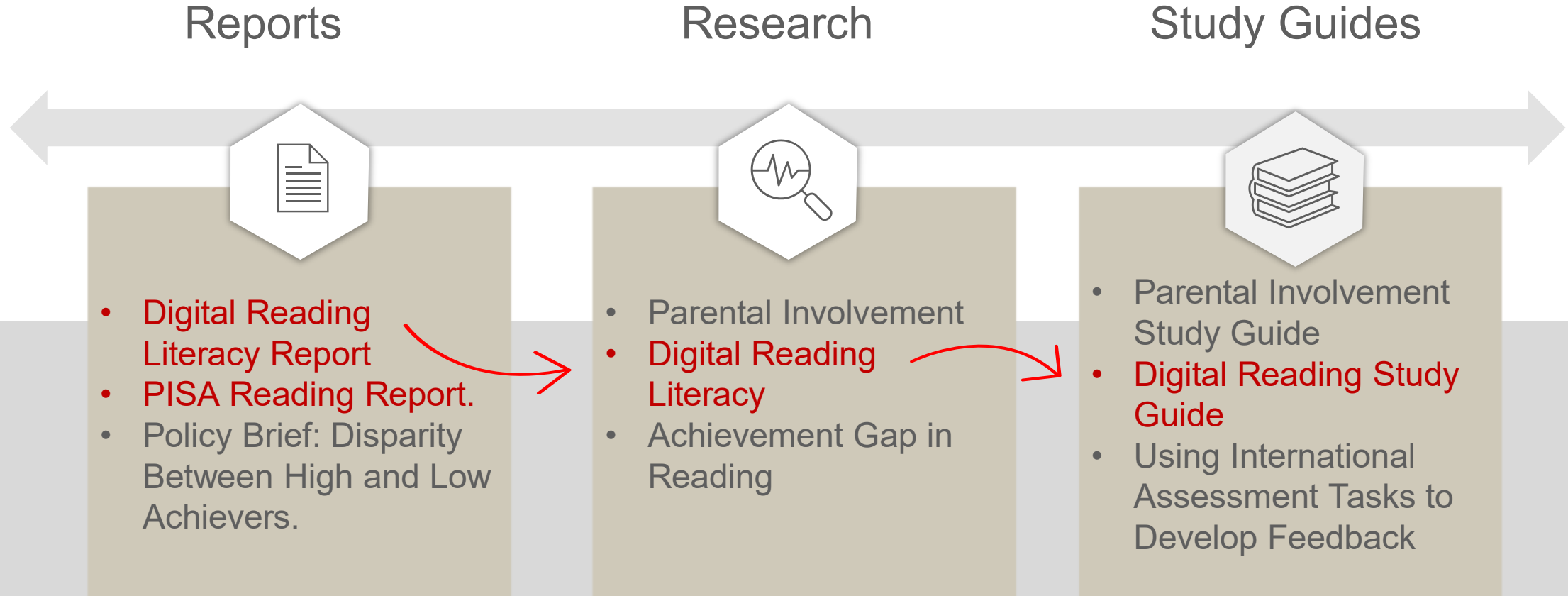

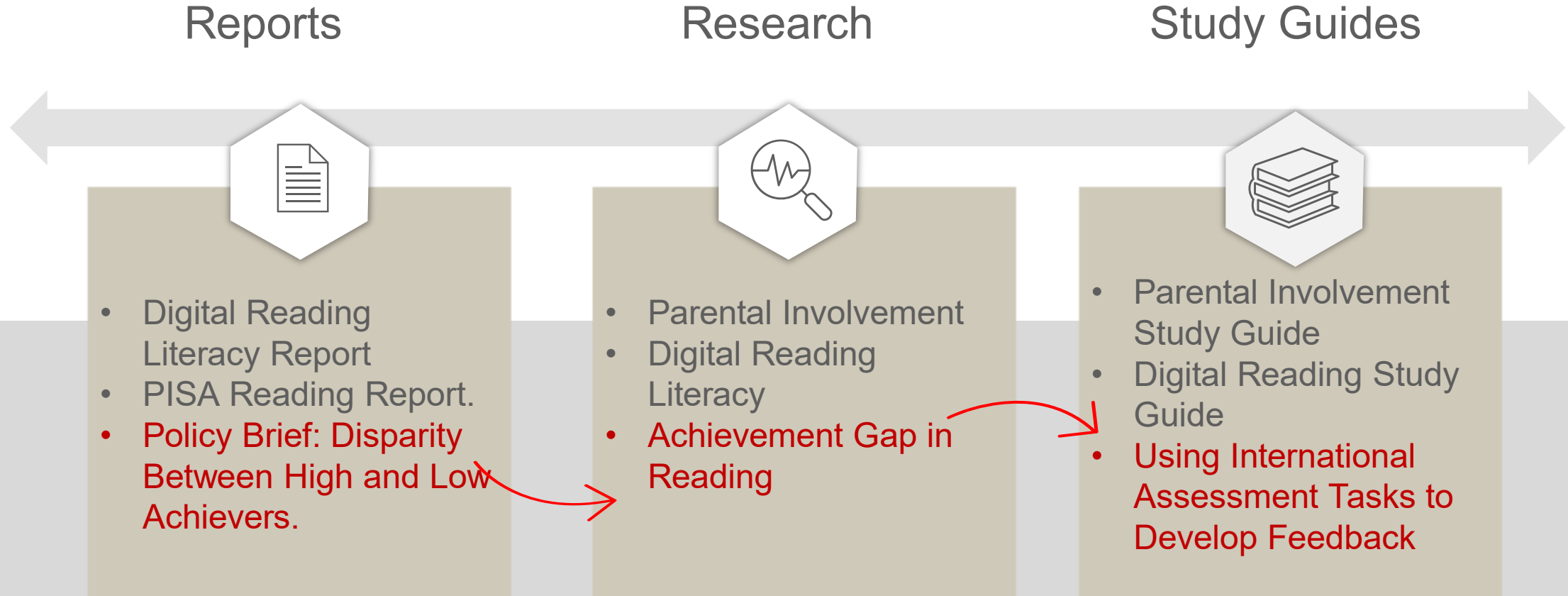

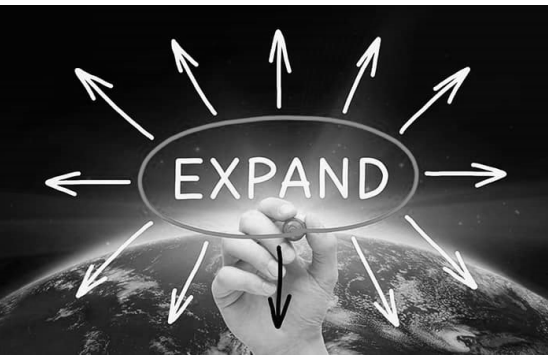
