



## Mirakl Website Privacy Policy

*Last updated: February 2019*

Mirakl (“Mirakl”, “we” or “us”) takes your privacy very seriously. This Policy describes Mirakl’s privacy practices regarding the use of personal data in its websites. More precisely, it explains what data we collect, how we use, store and/or transfer it.

This Policy applies to individuals who visit (“visitor”, “you” or “yours”) Mirakl’s Website (“website”) and covers the following website: miraklsummit.com

### What data we collect and how we use it

#### Forms

Our websites contain contact forms. When you “request an invitation” or you try to “contact us” via these forms, we require you to submit your contact information which contain personal: full name, email, phone number, country, company name and job title. We may use your contact information to send you offers about our services. You can opt-out of future mailings at any time by clicking on the “unsubscribe” button located at the bottom of the emails you receive.

#### Browsing data

When you visit our websites, we automatically collect your browsing data that may include your IP address, device, your region, your browser type, your internet service provider and/or mobile carrier, the pages and files you viewed, your searches, your operating system and system configuration data, and the date and time of your visit.

Some of the above data is used to create general statistics which allow us to assess the number of visitors to our website, identify what pages are visited most frequently and, ultimately, make the website more user friendly.

#### Cookies

Cookies are small text files that are placed in your computer by the websites you visit. They are widely used in order to makes websites work, or work more efficiently, as well as to provide information to the owners of the website.

#### Our cookies

We mainly use cookies that are session-based. They typically store data in the form of a session identification that does not personally identify you. Session cookies exist during one session. They disappear from your computer or device when you close your browser software or turn off your computer.

You can control the use of cookies at the individual browser level, but if you choose to disable cookies, it may limit your use of certain features or functions on our websites.

## Third-party cookies

We also use cookies delivered by third parties for statistical and advertising purposes. These cookies are governed by their own privacy policies. If you wish to opt-out third-party cookies, please check their privacy policies by clicking on the links below.

They provide information regarding the number of visitors to the sites, where visitors have come to the site from and the pages they visited. ## **Web beacons**

Mirakl uses web beacons alone or in conjunction with cookies to compile information about prospects and visitors' usage of its websites and interaction with emails from Mirakl. Web beacons are clear electronic images that can recognize certain types of information on your computer, such as cookies, when you viewed a particular website tied to the web beacon, and a description of a website tied to the web beacon. For example, Mirakl may place web beacons in marketing emails that notify it when

you click on a link in the email that directs you to one of the Mirakl's websites. We use web beacons to operate and improve Mirakl's websites and email communications.

## **Customer testimonials**

Mirakl posts customer testimonials videos on the websites that contain data such as customer names and titles. Mirakl has obtained the consent of each customer before posting any data on such testimonials.

## **With whom we share it**

### **Mirakl affiliates**

Mirakl may share data about its prospects with its affiliates in order to work with them. For example, Mirakl may need to share data with its affiliate for marketing, and account management purposes.

### **Third-parties**

Sections "Cookies" and "Web beacons" of this Policy, specifically address the data we or third parties collect through cookies and web beacons, and how you can control cookies through your web browser. Mirakl does not sell data to any third parties.

### **Compelled disclosure**

Mirakl reserves the right to use or disclose information if required by law or if Mirakl reasonably believes that use or disclosure is necessary to protect Mirakl's rights and/or to comply with a judicial proceeding, court order, or legal process.

### **Retention**

We retain personal data only as long as necessary for using it in accordance with the purposes described in this Policy, or as otherwise necessary to comply with applicable laws. When your data is no longer necessary or relevant for our purposes, or required by applicable laws, we take steps to have it deleted or made anonymous.

## **Your rights**

In the event of an unsatisfactory response, you are entitled to lodge a complaint with a supervisory authority.

## **How we protect your data**

Mirakl puts in place all the necessary measures to protect your data from unauthorized access to, disclosure, alteration, or loss. In particular, we use SSL certificates to encrypt our websites and only a limited number of staff have access to the data we use. We review and update our practices regularly to enhance your privacy and ensure that our internal policies are followed.
