



Legal frameworks across levels of government

National level



- 7 countries adopted national **framework laws**
- 30 countries adopted almost 100 national **specific laws**
- **Acceleration of national-level laws** among target countries in recent years

Subnational level



- Intervene in the **absence of/or to complement** national laws
- It is the case in **federal states** such as Brazil, Canada, India, Spain and the United States
- In Korea, **cities** such as Seou have pioneered new approaches to regulating the SSE, particularly social enterprises
